### Risk Statement

RRS Rule 3 of the Racing Rules of Sailing states: “The responsibility for a boat’s decision to participate in a race or to continue racing is hers alone.” Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omission;
- d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.
- h) They are responsible for ensuring that their boat is equipped and seaworthy so as to be able to face extremes of weather; that there is a crew sufficient in number, experience and fitness to withstand such weather; and that the safety equipment is properly maintained, stowed and in date and is familiar to the crew.
- i) Their boat is adequately insured, with cover of at least £3,000,000 against third party claims.

A Minimum Entry Fee of **£10 per boat** (£0 for Under 18s) may be paid on Regatta Day on the beach or to one of the Entry Boats or by electronic transfer of funds (mobile/internet banking) before noon on 7<sup>th</sup> June 2025 to the bank account of St Feock & Pill Creek Regatta, Lloyds Bank, Truro, Sort Code 30-98-76, Account Number 00353159 a reference of the Skipper Name, Boat Name and/or Sail Number. ### Risk Statement

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By allowing my child to participate in Racing I, the parent/guardian of the child mentioned above agree and acknowledge that:

- I am aware of the inherent element of risk involved in the sport and accept responsibility for exposing my child to such inherent risks;
- I have satisfied myself that my child has the necessary skill and knowledge to take part in RYA Junior Racing and to deal with conditions that may arise in the course of a race;
- I will not allow my child to participate in Racing whilst under the undue influence of alcohol, drugs or whilst otherwise unfit to participate;
- I am responsible for ensuring that the boat is in good order, equipped and insured (including third party insurance of at least £3 million);
- I am responsible for my child's property whether afloat or ashore;
- I accept responsibility for any injury, damage or loss to the extent caused by my own actions or omissions or actions or omissions of my child;
- the provision of a race management team, patrol boats and other officials and volunteers does not relieve me of my parental/guardianship responsibilities or my child of his/her responsibilities;
- the provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- It is your responsibility to familiarize yourselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.

### Acceptance of the Rules

- My child is bound by the Notice of Race, Sailing Instructions and Racing Rules of Sailing (RRS); and
- I am aware of the RYA Prescription to RRS Rule 4 and that my child may be penalised under the RRS for any misconduct on the part of my child's *support persons*.
